## YouthPass Terms and Conditions

The following terms and conditions apply to the YouthPass:

1. Passholder must be 18 years of age and under to qualify.
2. The YouthPass is for exclusive use on the Victoria Regional Transit System. It is valid on all routes and all days.
3. The YouthPass must remain in the owner's possession during travel, and cannot be used by anyone other than the owner of the pass.
4. The YouthPass is valid only when electronically swiped at the farebox and valid only from the start date until the expiry date shown on the front of the pass.
5. The pass holder must notify BC Transit that his or her bus pass is lost or stolen and to arrange a replacement pass. A \$25.00 replacement fee is charged.
6. A YouthPass that is damaged, defaced, or mutilated in any manner may be confiscated by BC Transit and is subject to a \$25.00 replacement fee.
7. BC Transit has the right to cancel the pass if it deems these terms and conditions are not met.
8. YouthPass is not valid on handyDART.

## YouthPass Fees

1. There is a \$25.00 replacement fee for lost or stolen or seized passes.
2. A NSF fee of \$25.00 applies. An outstanding balance must be paid in cash or money order only.
3. In special circumstances, pass cancellation or refund is allowed. A refund is given on any full month remaining less a \$25.00 processing fee.
4. Cancellation of the YouthPass by a parent or guardian is complete only when the YouthPass is physically returned to BC Transit.
5. BC Transit refunds by cheque only.
